Monthly Commentary (June 2023)

During the month our trend following methodology introduced positions in US and emerging equities and exited corporate and high yield fixed income (bonds). This left the fund with about 47% in risk assets and the rest in cash or cash-equivalent risk-free assets.

To read the financial press you might assume that the world is mired in low growth and high inflation. In the year to June 30th 2023, GDP growth in the USA was 1.6%, in China 4.5% (allegedly), in Japan 1.9%, in the UK a disappointing 0.2% and in the Euro Area 2.2%. Inflation seems to have been tamed somewhat with the CPI rising by 4.0% in the USA, 0.2% in China, 3.2% in Japan (where an inflationary revival is to be welcomed), 8.7% in the UK (again the outlier) and 6.1% in the Euro Area. Budget deficits are worrying everywhere (e.g. 5.4% in the USA) but this is not surprising as governments try to wean themselves off the deficit financing which was the policy response to the nandemic. Bond yields have risen considerably, with 10 year US Treasuries at 3.7% and an average in the Euro Area at 2.3% but there are hints that these may be peaking as both central banks and markets sense that inflation may be moderating. Such a view is supported by the all-items commodity index falling by 11.8% year to date, against which Russia's refusal to renew the Black Sea grain deal and its threat to Black Sea shipping are not encouraging. Energy prices were an immediate cause of the recent inflation and indeed Brent Crude is now +38.3% year to date. Equity markets have responded well to the prospect of an easier monetary environment with the S&P 500 leading the way at +29.9% year to date.

During June the Global Multi Asset Fund retreated by 0.6%. We would note that since inception the fund is outperforming UK gilts, the classical diversifier for a UK portfolio, by just over 16%.
